## Contract

In all other cases and except where inconsistent with the above any person flying, learning to fly, training to fly, flying in any aircraft being used for or in connection with Gyroplane flying or participating in any activity carried out by this Association does so entirely at their own risk.

It is a condition of admission to membership of this Association that this Association, its Office-bearers, Committee (hereafter referred to as 'Board') persons, members and servants or agents are absolved from all liability howsoever arising for injury or damage howsoever caused (and whether fatal or otherwise) arising out of the membership of this Association or participation in flying, learning to fly, training to fly, flying in any aircraft being used for or in connection with Gyroplane flying or in any way caused by or arising out of any activity carried on by this Association whether or not such injury or damage is in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of this Association, its Office Bearers, Board persons, members or servants or agents.

Any persons flying, learning to fly, training to fly, flying in any aircraft being used for or in connection with Gyroplane flying or participating in any activity carried on by this Association are only allowed to do so on the distinct understanding that they do so entirely at their own risk.

I, the applicant, have read, or have had read to me the above warning and having understood same, and consent to the activity proposed.
